

**Details of Notice Inviting Quotation for making of Bronze Bust Statue of Late Kanak Lal Barua and Late Hemchandra Goswami**

**A. Name of the work** : “Preparation and installation of Bronze Bust Statue of Late Kanak Lal Barua and Late Hemchandra Goswami”

**B. Scope of work** : Preparation and installation of two bronze bust statues including pedestal of Late Kanak Lal Barua and Late Hemchandra Goswami at the Assam State Museum

**C. Details of work** :

Sl. No	Particulars	Details
1	Clay Modelling of two busts	3.5 feet approx for each bust.
2	Metal casting of two busts	Bronze with minimum thickness of 3 mm for each bust.
4	Two pedestals and their installation	4 feet for each bust Iron, Bricks, Plaster, Granite, Metal plaque with lettering, labour, transportation etc.

**D. Estimated value of Work : Rs. 12,00,000/- (Rupees twelve lakhs) only inclusive of all taxes..**

The quotation has two separate bids, one technical and the other, financial bid.

**Terms & Conditions for the Technical bid :**

1. Technical bid shall be quoted in a separate envelope.
2. An application stating the offer of the tender and signed copy of the tender document must be submitted as an acceptance of the overall terms and conditions.
3. The firms will have to submit the work profile of the artist who shall take up the work. The artist's profile will be analyzed by the tender committee and the decision of the committee will be final.
4. Self attested copy of PAN to be submitted.
5. Self attested copy of valid Trade License to be submitted.
6. Self attested copy of GST registration
7. Any tenderer who fails to comply with the above mentioned documents will be disqualified from financial bidding.

**Terms & Conditions for the Financial bid :**

1. Financial bid shall be quoted in a separate envelope.
2. The financial bid shall include all applicable taxes.
3. The undersigned is not bound to accept the lowest rate of any tender and reserves the right to accept or reject any or all tenders without assigning any reason thereof. The undersigned also reserves the right to cancel the Work Order before its expiry if the work done for any reason is found to be unsatisfactory. In case of any dispute, the decision of the Assam State Museum Management Society will be final and binding.
4. The cost of the tender is NIL. The tender documents are not transferrable.
5. The rate should be indicated in figures as well as in words and all entries in the tender form should be legible and filled clearly. No overwriting or cutting is permitted in the Bid Form; or else the tender shall be summarily rejected.
6. The rates quoted by the bidders shall remain the same till the completion of the bid validity period and price variation shall not be entertained.

**General Terms & Conditions :**

1. Technical & Financial Bids should be put in two separate envelopes superscribed with the name of the work and addressed to the undersigned. The name of the vendor with address and contact number be clearly written at left bottom of the envelope.
2. Payment on completion of work is subject to the financial sanction and release of funds as per prevailing rules and procedures. No interest will be paid due to delay in release of payment, if any.
3. The firm should be able to complete the work within 90 days from the issue of Work Order. If the firm fails to complete the work within the prescribed time, it would be liable to face the penalty by the competent authority.
4. In case of inferior/ substandard use of quality or quality used not according to the approved specification, the ASMMS will have the right to reject the complete work and cancel the agreement.
5. The work done will be reviewed by a Committee, comprising of Director of Museums, Curator, Assam State Museum, Assistant Architect, Assam State Museum and Artist, Assam State Museum in all stages of the work including approval of clay modelling as per photograph, purity of metal to be used, metal casting and installation.
6. Minimum three designs of pedestal have to be submitted along with the bid.
7. Supply and installation of surface-mounted LED spotlight with minimum IP65 grade in cast iron or aluminum body will have to be carried out by the contractors. The luminaries shall be surface mounted with adjustable projection angle and 3000K CCT value from a reputed make as approved by the authority complete with all necessary wiring etc.

8. Supply and installation of 3d extruded text in brass or bronze as per the artistic theme with minimum 1.5" high 3mm extrusion in specified language(s), fixed to natural stone cladding of the base complete with all necessary industrial grade adhesive, cleaning and polishing etc. will have to be made by the contractor.

9. All disputes are subject to the jurisdiction in Kamrup (Metro) Assam.
